- Copy of a LA Fire Marshall Inspection
- Copy of a Parish Health Inspection

Once copies of all documents requested above have been received and the payment of 1,500.00 has been paid, LSBEFD will have the inspector to contact you to schedule your inspection for your new funeral establishment.

Please be mindful, if a re-inspection must be carried out, a \$500.00 fee will be required prior to the next scheduled re-inspection.

- Copy of your Partnership, Joint Venture, or Articles of Incorporation
- Copy of an Act of Sale or Lease Agreement
